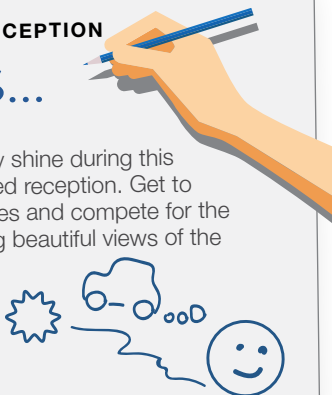

## TECHNOLOGY AND THE TRUCK

This presentation will discuss the history of driver distraction analysis and science behind DOT's decision to allow hand's free communication.

- Accident reconstruction/animations – that's really neat!
- ECM data versus satellite information (e.g., “Peoplenet”) – not infallible, look closer

- Electronic log improprieties – are they all the same?
